A filter pot ruptured an O-ring causing a release of 32 BBLS PW inside of the containment. The filter pot was isolated to prevent any further release from occurring. Repairs will be made to the equipment.

Describe Area Affected and Cleanup Action Taken.*
Approximately 32bbls produced water was released inside the lined containment. All 32BBLS of released produced water remained in the containment and was recovered back to the tanks through a sump pump at the facility. The containment and liner were visually inspected and placed back into service.
