We have recently completed our State 157 "G" Well No. 3 located 990 feet from the North and East lines of Section 5, T-22S, R-36E, Lea County, New Mexico, in the Jalmat Gas Pool and it is requested that administrative approval of a non-standard proration unit consisting of the 160 acres located in the Northwest Quarter of Section 5-22S-36E be approved for this well.

This 160 acres non-standard unit requested for our Well No. 3 is presently dedicated to our State 157 "G" Well No. 1 in the Jalmat Gas Pool and was approved by the Oil Conservation Commission's Order NSP-183 dated September 2, 1955. Our State 157 "G" Well No. 1 is dead and has been shut in.


