



Additional interest owners are not identical and notification of commingling is required.

Oil & Gas Production & Allocation

Oil gas and water production from the Federal 13 and Federal 13 Com wells comes into a production header then flows to a dedicated two-phase production separator. The production then flows to a three-phase heater treater.

Oil production then flows to individual oil meters for measurement: Federal 13 Com #8H – 300001037P, Federal 13 #9H – 300001034P and Federal 13 Com #10H – 300001031P. After measurement oil then flows to oil tanks for storage and additional measurement. Finally, sales flow through LACT meter # F13CTB.

The oil gravities are equivalent (see Exhibit B). The oil allocation meters will be calibrated on a regular basis per API, NMOCD and BLM specifications. The BLM and OCD will be notified of any future changes in the facilities.

Gas Production: is not commingled. Custody transfer meter for each well : Federal 13 Com #8H: 300001037; Federal 13 #9H – 3000001034; and Federal 13 Com #10H: 300001031H.

Process & Flow Description:

Please see attached process flow diagram for the Federal 13 central tank battery.

The commingling of the oil production is in the interest of conservation and waste. It will result in the most effective economic means of producing the reserves in place from the affected wells and will not result in reduced royalty or improper measurement of the gas production. The proposed commingling reduces the surface facility footprint and overall emissions.

Cimarex understands the required approval will not constitute the granting of any right of way or construction rights not granted by the lease. These applications will be submitted separately for approval per NMOCD and BLM regulations.
