Devon did not order the tanks nor were we contacted and asked permission to have the tanks placed on our location. Devon was only made aware of the fire that occurred because we were contacted by the fire department who extinguished the fire which occurred on the tanks which were set by the 3rd party contractor.

After reviewing this incident with OCD, Devon is submitting this in cooperation with OCD to allow a path for this incident to be closed.

Hello all,

OCD District II Office received a faxed Initial C-141 form today from a non-operator reporting a release that had occurred on what appears to be a federal administered surface location. I spoke with a representative of the organization called Juniper Tanks LLC of whom which had submitted this Initial C-141 form to us. They stated that they were told they had to be the one to turn in the C-141 regulatory form to us cause it was their tanks that had an issue at the location. I informed them that if the location is a location leased by Devon Energy then Devon Energy needs to report the release to all appropriate parties. They were very insistent that they were told that they must be the ones to fill out the form.

Devon Energy folks, please make sure that all members of your organization who are willing to speak to or offer to dictate what our OCD reporting procedures involve/require that they are properly versed of such matters before doing so.

I also told this person from Juniper Tanks LLC that if they had some sort of liability for the release then that was between them and Devon to figure out. We are unable to accept this C-141 form as it is not properly produced. **OCD requires that Devon Energy inform OCD (as well as any other relevant regulatory parties) on the matters of this release as soon as possible.**

Fire department put out fire and residual water was removed approximately 10 barrels.
