Reference is made to your application received on April 27, 2018.

You have requested to recomplete this vertical well as a gas well described above in the referenced pool or formation. This existing well is now an unorthodox gas well and is govern by special rules for the Basin Fruitland Coal (Gas) which governs this pool and provides for 320-acre units, with wells located at least 660 feet from a unit outer boundary.

This well's completed interval is as close as 530 feet to the northern edge, and 816 feet to the northeastern edge of the project area. Encroachments will impact the following tracts.

Section 36, T29N R09W encroachment to the N2  
Section 31, T29N R09W encroachment to the NW4
