Dear Mr. Lowe:

OXY USA Inc. respectfully requests administrative approval of a non-standard location on the Platinum MDP 34-3 Federal Com #5H well, API Number-30-015-pending, Property Code pending. The #5H well is proposed to be completed in the Ingle Wells; Bone Spring pool, Pool Code 33740. This will be a horizontal well in a pool with no special rules for setback, so the setback requirements under Rule 19.15.15.9 (A) and 19.15.16.15 (B) would apply. The proposed producing interval is outside of the proposed Producing Area but within the proposed Project Area and will be drilled as follows:

Surface – 110 FNL 968 FEL Unit A Sec 34 T23S R31E
Top Perforation – 340 FNL 1260 FEL Unit A Sec 34 T23S R31E
Bottom Perforation – 340 FSL 1260 FEL Unit P Sec 3 T24S R31E
Bottom Hole – 180 FSL 1260 FEL Unit M Sec 3 T24S R31E

The adjoining spacing units towards which the unorthodox location encroaches are located in T23S R31E: Section 27- Unit O, Section 34-Units B, G, J, O, and T24S-R31E Section 10- Unit B.

Approval of the unorthodox producing interval will allow for efficient spacing of horizontal wells and thereby prevent waste.
