Describe Cause of Problem and Remedial Action Taken.*
Operator discovered water leaking from tank valve. He immediately isolated the tank and called to have water tank drained and replaced valve. Leak in tank valve was due to corrosion.

Describe Area Affected and Cleanup Action Taken.*
Hilcorp Energy Company used a vac truck to recover 5bbls of produced water. The berm area is lined but contained gravel on the top. Hilcorp hydrovaced the gravel off of the liner and found three holes. The liner will be opened up where the holes are to assess the soil. Once the soil is assessed Hilcorp will determine a path forward and will provide OCD 48 hour notice prior to sampling.
