Devon Energy Production Company, L.P. ("Devon") respectfully requests administrative approval of an unorthodox well location for the **Tomb Raider 1-12 Fed 514H** well to be completed in the Livingston Ridge; Bone Spring Pool (39350). As shown on the enclosed C-102, the permitted surface location is 360' FNL and 2365' FEL of Section 1-T23S-R31E, with a permitted bottom hole location 330' FSL and 2520' FEL of Section 12-T23S-R31E, Eddy County, NM. The projected FTP (first take point) is expected to be approximately 100' FNL and 2520' FEL of Section 1-T23S-31E and projected LTP (last take point) is expected to be approximately 100' FSL and 2520' FEL of Section 12-T23S-R31E. The reason for permitting this well at an unorthodox location is to maximize recovery.

Please be advised that Devon owns 100% of the Federal leasehold interest in all of Sections 1 and 12-T23S-R31E. COG Operating, LLC ("COG") is the leaseholder of offsetting interest to the north in Section 36-T22S-R31E offsetting to the north. Devon and numerous additional non-operating working interest owners ("WI Owners") are the leaseholders of offsetting interests to the south in Section 13-T23S-31E. COG and the WI Owners have been notified of this application via certified mail to the address shown on the enclosed list labeled "Notified Parties".


