Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed Palmillo 14-15 State Well No. 302H. This well will be drilled as a horizontal development oil well in the Southwest Palmillo-Bone Spring Pool (96413) at the unorthodox oil well location described above.

The proposed Palmillo 14-15 State No. 302H will be dedicated to a standard 320-acre horizontal spacing unit comprising the N/2 S/2 of Section 15 and the N/2 S/2 of Section 14, both in Township 19 South, Range 28 East, NMPM, in the Southwest Palmillo-Bone Spring Pool.

The proposed 320-acre horizontal spacing unit overlaps two existing 160-acre horizontal spacing units in the Southwest Palmillo-Bone Spring Pool comprising: i) the N/2 S/2 of Section 15, currently dedicated to the proposed Palmillo 14-15 State No. 206H; and ii) the N/2 S/2 of Section 14, currently dedicated to the existing Palmillo 14 State Well No. 1H, both units currently operated by Apache Corporation.

The Southwest Palmillo-Bone Spring Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units.

Pursuant to Division Rule 19.15.16.15, the completed interval of a horizontal well is required to be a minimum of 330 feet from the outer boundary of the horizontal

spacing unit measured along a line perpendicular to the completed interval, and the first and last take points of the well are required to be no closer than 100 feet to any outer boundary of the spacing unit.

The affected offset tracts are:

- 1) the S/2 S/2 of Section 15. This tract is an existing 160-acre horizontal spacing unit in the Southwest Palmillo-Bone Spring Pool currently dedicated to the Apache Corporation Palmillo 14-15 State No. 205H. Working interest owners in this tract in the Bone Spring formation include Apache Corporation, ZPZ Delaware 1, LLC, (a wholly owned subsidiary of Apache Corporation) and Marathon Oil Permian, LLC.
- 2) the S/2 S/2 of Section 14. This tract is an existing horizontal spacing unit in the Southwest Palmillo-Bone Spring Pool currently dedicated to the existing Apache Corporation Palmillo 14-15 State Well No. 2H and Palmillo 14-15 State Well No. 301H. Working interest owners in this tract in the Bone Spring formation include Apache Corporation, ZPZ Delaware 1, LLC and Penroc Oil Corporation.

Notice of this application is being provided to Marathon Oil Permian, LLC and Penroc Oil Corporation.

The proposed unorthodox well location is necessary to allow Apache Corporation to drill wells at optimum locations in order to effectively and efficiently produce the oil and gas reserves underlying the N/2 S/2 of Sections 14 and 15, thereby preventing waste.

Attached is an approved Form C-101, a C-102 showing the proposed well and proposed spacing unit, and a plat showing the affected offset tracts and wells.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Southwest Palmillo-Bone Spring Pool underlying the N/2 S/2 of Sections 14 and 15 that may otherwise not be recovered by the existing or proposed producing wells, thereby preventing waste.






