Pursuant to Rule 3 of the Special Rules for the Purple Sage-Wolfcamp Gas Pool and NMAC 19.15.16.15(B)(5), Devon Energy Production Company, LP ("Devon") (OGRID 319562) seeks administrative approval of a 200-acre non-standard horizontal spacing unit comprised of the E/2W/2 of Section 27 and the NE/4NW/4 of Section 34, Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico. The proposed non-standard spacing unit will be dedicated to the Lusitano 27-34 Fed Com No. 713H Well; the Lusitano 27-34 Fed Com No. 733H Well, and the Lusitano 27-34 Fed Com No. 622H Well.

The proposed wells will develop the Wolfcamp formation (Purple Sage; Wolfcamp Gas Pool (98220)). Pursuant to the Special Rules for the Purple Sage-Wolfcamp Gas Pool, set forth in Order No. R-14262, and NMAC 19.15.16.15(B)(3) and (4), an operator may elect to build standard gas spacing units out of standard 160-acre or 320-acre tracts. NMAC 19.15.16.15(B)(5) authorizes administrative approval of non-standard spacing units to prevent waste and protect correlative rights in conformance with NMAC 16.15.15.11(B). Devon seeks approval of this non-standard spacing unit to most efficiently develop the Wolfcamp in this area. The request for a non-standard spacing unit is due to the boundaries of XTO's adjacent Poker Lake Unit. All tracts excluded from the proposed spacing unit are within the boundaries of the Poker Lake Unit.

Exhibit A is a copy of the Well Location and Acreage Dedication Plat (Form C-102) for the each of the proposed wells and spacing unit.

Exhibit B is a map showing the proposed well and the proposed non-standard spacing unit in the E/2W/2 of Section 27 and the NE/4NW/4 of Section 34. The outline of XTO's Poker Lake Unit is shown in grey and purple. The tracts affected by this request are all of Sections 27 and 34. All acreage affected by this application is operated by either XTO or Devon. Devon owns 100 percent of the working interest in the E/2 of Sections 27 and 34.
