Dear Mr. Wade:

Percussion Petroleum Operating, LLC ("Percussion") (OGRID No. 371755) seeks administrative approval of an unorthodox well location for its **Lakewood Federal 15H Well** (API Pending) to be completed within a 160-acre horizontal well spacing unit in the N. Seven Rivers; Glorieta Yeso Pool (Pool Code 97565) underlying the W/2 W/2 of Section 34, Township 19 South, Range 25 East, N.M.P.M., Lea County, New Mexico. This well will be drilled from a surface location 430 feet from the north line and 1,270 feet from the west line (Lot 4) of Section 3, Township 20 South, Range 25 East. The first take point will be located 100 feet from the south line and 1,205 feet from the west line (Unit M) of Section 34 and the last take point will be 100 feet from the north line and 1,205 feet from the west line (Unit D) of Section 34. Since this acreage is governed by the Division's statewide rules, the completed interval for this well will be unorthodox because it is approximately 115 feet from the eastern boundary of the spacing unit. Approval of the unorthodox completed interval will allow Percussion to use their preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

**Exhibit A** is a Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Lakewood Federal 15H Well** encroaches on the tract to the east.

**Exhibit B** is a land plat for Section 34 and the surrounding sections that shows the proposed **Lakewood Federal 15H Well** horizontal well spacing unit in relation to adjoining tracts.
