AMENDS ADMINISTRATIVE ORDER PLC-480

Pursuant to your application received on March 11, 2019, OXY USA WTP Limited Partnership (OGRID 192463) is hereby authorized to surface commingle oil and gas production from the following pools located in Township 20 South, Range 38 East, NMPM, Lea County, New Mexico;

NADINE; PADDOCK-BLINEBRY, WEST	(47400)
NADINE; TUBB, WEST	(47530)
SKAGGS; DRINKARD	(57000)
SKAGGS; GRAYBURG	(57380)

and from wells, and their associated leases and pools identified in Attachment A and made part of this order. These wells are located in Township 20 South, Range 38 East, NMPM, Lea County, New Mexico.

Commingled oil and gas production from the wells shall be measured and sold at the Fred B Turner Jr. Facility Tank Battery (CTB), located in Unit I of Section 18, Township 20 South, Range 38 East, NMPM, Lea County, New Mexico.

Production from the subject wells shall be determined as follows:

The oil and gas production from the wells in this application shall be measured with a combination of metering and well testing. Each well shall be tested at least once a month

The allocation meters shall be calibrated quarterly in accordance with Division Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules and Regulations.

The Operator shall notify the transporter of this commingling authority and the Hobbs District Office prior to implementation of commingling operations.

For future additions of wells and leases to this commingling operation, notice shall only be given to those interest owners in the wells and leases to be added, in accordance with Division Rule 19.15.12.10 C (4) (g) NMAC.


Subsequent wells within leases approved by this order may be added to this administrative surface commingle application with a Sundry notice to the Engineering Bureau.

This administrative order supersedes administrative order PLC 480, issued on August 1, 2017. The Fred Turner Jr B Well No. 2 has been recompleted to the Skaggs; Grayburg Pool.

This installation shall be installed and operated in accordance with the applicable Division Rules.

It is the responsibility of the producer to notify the transporter of this commingling authority.

The Operator shall notify the transporter of this commingling authority and the Hobbs District Office prior to implementation of commingling operations.
