Pursuant to your application received on March 11, 2019, OXY USA WTP Limited Partnership (OGRID 192463) is hereby authorized to surface commingle oil and gas production from the following pools located in Township 20 South, Range 38 East, NMPM, Lea County, New Mexico;

and from wells, and their associated leases and pools identified in Attachment A and made part of this order. These wells are located in Township 20 South, Range 38 East, NMPM, Lea County, New Mexico.

Commingled oil and gas production from the wells shall be measured and sold at the McKee Unit Central Tank Battery (CTB), located in Unit H of Section 18, Township 20 South, Range 38 East, NMPM, Lea County, New Mexico.

Production from the subject wells shall be determined as follows:

The oil and gas production from the wells in this application shall be measured with a combination of metering and well testing. The wells in this application shall share a production tester. The Warren McKee will flow through a production header to either the test or production separator. The MJ Raley and Fred Turner wells shall flow dedicated production header to the tester or production or the production separator. Each well shall be tested at least once a month.

The allocation meters shall be calibrated quarterly in accordance with Division Rule 19.15.12.10.C (2) NMAC.

For future additions of wells and leases to this commingling operation, notice shall only be given to those interest owners in the wells and leases to be added, in accordance with Division Rule 19.15.12.10 C (4) (g) NMAC.


Subsequent wells within leases approved by this order may be added to this administrative surface commingle application with a Sundry notice to the Engineering Bureau.

This administrative order supersedes administrative order PLC 142-10, issued on August 8, 2017. The Fred Turner Jr C Well No. 1 has been recompleted to the Skaggs; Grayburg Pool, and the Warren McKee Well No. 112 has been removed.

This installation shall be installed and operated in accordance with the applicable Division Rules.

It is the responsibility of the producer to notify the transporter of this commingling authority.

The Operator shall notify the transporter of this commingling authority and the Hobbs District Office prior to implementation of commingling operations.
