

A. The following well data must be submitted for each injection well covered by this application. The data must be both in tabular and schematic form and shall include:

- (1) Lease name; Well No.; Location by Section, Township and Range; and footage location within the section.
- (2) Each casing string used with its size, setting depth, sacks of cement used, hole size, top of cement, and how such top was determined.
- (3) A description of the tubing to be used including its size, lining material, and setting depth.
- (4) The name, model, and setting depth of the packer used or a description of any other seal system or assembly used.

Division District Offices have supplies of Well Data Sheets which may be used or which may be used as models for this purpose. Applicants for several identical wells may submit a "typical data sheet" rather than submitting the data for each well.

All applicants must furnish proof that a copy of the application has been furnished, by certified or registered mail, to the owner of the surface of the land on which the well is to be located and to each leasehold operator within one-half mile of the well location.


Mewbourne Oil Company hereby protests the above referenced application of Strata Production for a Devonian salt water disposal permit. APPLICATION

Strata Production Company ("Strata" or "Applicant"), through its undersigned counsel, Montgomery & Andrews, P.A., applies pursuant to 19.15.26.8 NMAC for an order authorizing injection of oil field produced water for disposal into the Devonian formation, Forty Niner Ridge, Devonian SWD pool (96100), in Eddy County, New Mexico. In support of its Application, Strata states as follows:

1. Applicant is the operator of the Sandy Federal SWD #10 well at a surface location 2,430 feet from the North line and 460 feet from the West line of Section 24, Unit E, Township 23 South, Range 30 East, Eddy County, New Mexico
2. Applicant proposes to drill the Sandy Federal SWD #10 to a depth of approximately 16,500 feet. Strata proposes to complete the well for injection of oil field produced water into the non-commercial Devonian formation at depths between 15,545 and 16,500 feet.
3. Applicant proposes to conduct injection operations through the well at an anticipated average injection pressure of 2,000 psi and maximum injection pressure of 3,120 psi. Applicant proposes injection volumes between 3,000 and 15,000 barrels per day with an average volume of 10,000 barrels per day. The source of injected fluids will be from Strata wells in the area as well as other operated Delaware and Bone Spring wells in the area.

4. Applicant's proposed injection operation can be conducted in a safe and responsible manner without causing waste, impairing correlative rights, or endangering fresh water, public health, or the environment.

5. Applicant filed its original request for administrative approval with the Oil Conservation Division on September 13, 2018. The Oil Conservation Division received a written objection, so the matter must be set for hearing pursuant to 19.15.26.8(D) NMAC, with notice given by the Oil Conservation Division.

6. Attached hereto as Exhibit A is the original application.

WHEREFORE, Strata requests that this Application be set for hearing before a duly appointed examiner of the Oil Conservation Division on January 24, 2019, and that after notice and hearing as required by law, the Oil Conservation Division enter its Order approving the utilization of the Sandy Federal SWD #10 for injection of oil field produced water into the Devonian formation at the intervals, pressures, volumes, and rates indicated, and making such other and further provisions as the Division determines is appropriate.
