Reference is made to your application dated January 11, 1966, for administrative approval to re-enter the Magnolia S. P. Johnson Well No. 1 located in the SE/4 SW/4 of Section 12, Township 9 South, Range 33 East, Lea County, New Mexico, and to drill out said well to a total depth of approximately 11,300 feet, and to complete the same as a tubingless completion for the production of gas through 3 1/2-inch casing.

It is our understanding that a dry, sweet gas is anticipated and that you do not expect to encounter any liquid problems in the production of gas. You are, therefore, authorized to complete and produce the subject well in accordance with the procedure outlined in your letter of January 11. The Commission does reserve the right, however, to review this matter at any time that it appears that waste may be resulting from the proposed method of production.

Attached hereto is a copy of a C-101 and a C-102 wherein I give notice of intention to re-enter the Magnolia S. P. Johnson #1 well located in the Southeast Quarter Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 12, Township 9 South, Range 33 East.

As outlined on the Form C-102, miscellaneous notices, I propose to re-enter the hole with 3 3/4" bit on 3 1/2" N 80 tubing and drill out the plug to a total depth of approximately 11,300 feet. As soon as total depth is reached, the string will be cemented with approximately 300 sacks of cement, as recommended by Halliburton and will then be perforated after waiting approximately 18 to 24 hours.

It is my proposal that this be, and I hereby request your approval of, a tubingless completion, using 3 1/2" N 80 tubing as casing and cementing the tubing 750 feet from total depth.

The well at the present time has 13 3/8" 48# casing at a depth of 450 feet with 400 sacks of cement, and 9 5/8" 36# and 40# casing at 4,900 feet with 1,200 sacks of cement.

The well was tested in 1956 by Magnolia for gas, which gas is apparently low fluid content, and a sweet gas.

Mr. J. D. Ramey of your Hobbs office advised that in absence of specific rules on this size of tubing for tubingless completion in this depth of a hole, the request for approval should be made by letter to your office and directed to the attention of Mr. D. S. Nutter.

Will rig up reverse circulating unit drill out plugs to a total depth of 11,300 feet. Drilling will be done with a 8 3/4" bit on 3 1/2" N 80 tubing. When total depth is reached, string will be cemented in with 300 sacks of cement, as recommended by Halliburton. Cement will be allowed to set a minimum of eighteen hours and well will be perforated between 11,150 and 11,200 feet.
