

Administrative Order TX-31

Gentlemen:

Reference is made to your application dated June 5, 1968, for administrative exception to the provisions of Rule 107 (d) (2) to permit the production of your Johnston Federal Well No. 4, located in Unit H of Section 33, Township 31 North, Range 9 West, Blanco Mesaverde Pool, San Juan County, New Mexico, through 7-inch casing from total depth to 4500 feet and through 4 1/2-inch casing from 4500 feet to the surface.

Union Texas is hereby authorized to produce the subject well in the aforesaid manner for so long as the flow is efficient and no liquid production problems present themselves, provided that you shall also obtain the consent of the United States Geological Survey.

The Commission does reserve the right, however, to require that the tubing be re-installed in the event that it appears inefficient flow or inaccurate tests result from this casing flow.

Permission is hereby requested for an exception to sub-paragraph (2), paragraph (d) of Rule 107, Casing and Tubing Requirements for the above captioned well.


Total depth of this well is 5513 feet in the Mancos with plug back total depth of 5370 feet at the base of the Mesaverde. The well is producing through perforations of the 5" liner. The 4-1/2" casing is cemented to the surface inside the 7" casing to alleviate any corrosion problems (see attached diagram).

A recent check of the well for stray current effect was made and none was found.

It is our belief that there will not be any waste caused by this exception but that ultimate recovery will be greater due to the elimination of excessive loss of pressure due to the friction caused by the high withdrawal rate.




At the present time we are producing this well with compressors. Average producing rate with 2-3/8" tubing in the well was 8600 MCFPD with corresponding tubing surface pressure of 324 psig. The tubing was pulled on March 22, 1968, and the well is presently producing 10,500 MCFPD with corresponding surface pressure of 435 psig. These pressures indicate excessive friction pressure with the tubing in the hole which can be eliminated by a tubingless completion.
