Dear Ms. Sandoval:

The original application stated that the surface location of the Lisa Turtle SWD #1 well would be 2180' FSL and 2290' FEL in Section 15, Township 23 South, Range 26 East, NMPM, Lea County, New Mexico. The amended location will be 2111' FSL and 2390' FEL, in Section 15, Township 23 South, Range 26 East, NMPM, Lea County, New Mexico. There are no other changes to the original application.

Enclosed is an amended form C-102 showing the correct footage calls for the surface location along with the correct plats and maps showing the revised location. This amendment is being made to satisfy concerns by Chisholm Energy Operating, LLC. Their concerns have all been addressed and Chisholm Energy Operating, LLC has waived objections to this well as shown in their letter to Solaris, dated April 2, 2019 which is also attached.

This change in location will not affect any other part of the application. The new AOR does not include any wells that were not addressed originally. Further, no additional adjacent operators were identified after the move, so no additional notifications are required. All other attachments to the original C-108 have not changed. The surface owner remains the same, however, Solaris is copying them on this letter so that they are aware of the new location.

Solaris Water Midstream, LLC ("**Solaris**") hereby agrees to indemnify Chisholm Energy Operating, LLC ("**Chisholm**"), it's subsidiaries and affiliates, and all successors or assigns from any and all claims, demands, losses, damages and liabilities (collectively "Liability") arising out of or related to Chisholm's future horizontal development in Sec. 15 as it might impact the Lisa Turtle SWD wellbore. Solaris agrees that Chisholm has notified Solaris of the potential risks related to the proximity of the Lisa Turtle SWD wellbore to Chisholm's proposed horizontal laterals in Sec. 15.

The provisions of this Agreement shall not apply to the extent that any such Liability results from negligence, gross negligence, or willful misconduct of Chisholm, its subsidiaries and affiliates, and all successors or assigns.

Chisholm does hereby consent to the location of the Lisa Turtle SWD at the proposed surface location ~2111' FSL and ~2390' FEL, Sec. 15, T23S-R26E, Eddy Co. NM.




LISA TURTLE SWD 1


LISA TURTLE SWD 1



