Attached is the Bone Spring production curve for the Todd "14K" Federal #1, which had initial production on 2/3/1999. This well produces into a single well battery at the Todd "14K" Federal #1 well site. The Bone Spring production graph that is attached illustrates the marginal production rates from the Bone Spring zone. DEC plans to allocate production by assuming any incremental production gain realized after the commingling of the Bone Spring and Wolfcamp would come from the Wolfcamp. Attached is an estimated Wolfcamp production graph for two years along with the corresponding tabular information. The decline rate for the first year is the same James Ranch Unit (Wolfcamp) wells which produce in Section 6 of the same township and range. The decline rate estimated during the second year is exactly one half of the previous year.

For zones with no production history, estimated production rates and supporting data.

DEC's estimated initial production rate for the Wolfcamp is based upon swab tests performed during recompletion activities. Both the Wolfcamp and Bone Spring are currently downhole commingled in five of the Bass Enterprises, Section 6, T23S, R31E, James Ranch Unit wells and are geologically correlative to the intervals being proposed for downhole commingling in the Todd "14K" Federal #1. Attached is a summary graph of the production from the five (#17, 30, 65, 73, & 76) James Ranch Unit wells. The decline for each product curve has been calculated and used as the basis for the projected decline curve of the Wolfcamp in the Todd 14-1. The decline rate for the first year of estimated Wolfcamp production is the same as the James Ranch Unit (Wolfcamp) wells. The estimated decline rate for the second year is one half that of the first.

Data to support allocation method or formula.

The attached spreadsheet printout of well tests from the Todd "14K" Federal #1 provides a good history of the Bone Spring production. This data indicates a fairly consistent production rate. Once commingled, the incremental production of the well will be allocated to the Wolfcamp with the remaining production being allocated to the Bone Spring.
