

Energen Resources Corporation requests administrative approval for downhole commingling the Tapacito Pictured Cliffs and Blanco Mesaverde pools in the subject well. The well is currently producing as a Pictured Cliffs/Mesaverde dual completion. The Pictured Cliffs zone has experienced liquid loading problems and it is felt downhole commingling will eliminate excessive operational expenditures and allow the Mesa Verde flowstream to aid in keeping the Pictured Cliffs zone unloaded and producing.
