Dear Mr. Stogner,

Due to an unmarked buried pipeline in existing approved location for the **Carter-Eaves "NCT-A" No. 3** (N-6-24S-37E), we are requesting a change of location, moving the well 50 feet to the east which will make the new location 512' FSL and 1973' FWL. This is due to the fact that there is an existing **Southern Union Gas Pipeline and a Water Disposal Line** next to the old approved location. To the north of the old approved location there is a pumping unit (Oxy-MLMU #174, 660' FSL & 1917' FWL). The only alternative is to move east away from all existing obstructions (see attached plat).

Also, please find enclosed an amended C-101 and C-102 showing the new location for the **Carter-Eaves "NCT-A" No. 3**. This change will affect NMOCD order #NSL-3025 (SD).




