BP America Production Company request permission to surface commingle production the Blanco Mesaverde, and Basin Dakota Pools from our Hardie LS #1 and from the Wilch A #1. Surface commingling Blanco Mesaverde production will consist of the Hardie LS #1 30-045-07893 and Basin Dakota production will be from the Wilch A #1 30-045-07902. The production from each well will be metered prior to commingling then the commingled production will flow into & through the separator where the liquids will be removed. The commingled gas will then be sent through compression prior to entering the sales meter. Please reference the attached schematics reflecting the Proposed Surface Commingling Layout provided for your reference.

The working interest, royalty and overriding royalty interest owners in the subject wells are identical. The proposed commingling of production is to reduce operating expenses between the wells and will result in increased economic life of the wells.
