
You asked for information on Devon's plans for another well in the offsetting NE~~X~~SE~~X~~ of Section 35. Attached as Exhibit 1 is a plat showing Devon's Glorieta-Yeso wells in the S~~X~~ of Section 35. Please note: (1) The leases in the SE~~X~~ of Section 35 derive from a single federal lease, with common overriding royalty ownership; and (2) there are six Glorieta-Yeso wells in the SE~~X~~, three of which are in the N~~X~~SE~~X~~. Therefore, Devon believes that the correlative rights of the interest owners in the N~~X~~SE~~X~~ of Section 35 are adequately protected.

Devon did permit a second well in the NE~~X~~SE~~X~~ of Section 35. However, that well has not been drilled, because it would be too close to the existing well in that quarter-quarter section.¹

¹The existing well is somewhat out of the northeast-southwest drilling plan because of surface considerations.


