This is to request administrative approval of an unorthodox location to be located in the West Kutz Pictured Cliffs Pool, San Juan County, New Mexico.


This well our Huerfano Unit, Well No. 65 is to be located 1185' from the West line and 1975' from the North line of Section 5, Township 26 North, Range 10 West, N.M.P.M., San Juan County, New Mexico. The southwestern portion of this 1/4 Section consists of the edge of a mesa with the remaining portion of the 1/4 Section consisting of ridges and dry washes which would make the cost of roads and location extremely expensive.

This well is to be a Pictured Cliffs test in the Huerfano Unit and since the offsets are in the Huerfano Unit, which El Paso Natural Gas Company is the operator, the approval of other operators has not been sought.

I am enclosing two copies of the Certified Well Location Plat sketching terrain conditions and two copies of our Intention to Drill.




