Gentlemen:

Under the provisions of Paragraph F, Rule 104, application is hereby made for administrative exception to Paragraph C, Rule 104 "Well Spacing", as revised by Order R-855. Attached is a certified plat of location for the State B#3 well. Also attached is a plat of the surrounding area which shows the location of the well with respect to the runway of the Lea County, New Mexico Airport. Austral Oil Exploration Company Incorporated leases are shown in yellow. It is further stated that -



- "1. The necessity for the unorthodox location is based on topographic conditions of the airport runway.
2. Austral Oil Exploration Company Incorporated owns all oil and gas leases within a radius of 660 feet of the well location with the exception of the lease on the east. This lease is owned by the Texas Pacific Coal and Oil Company and the State B-3 well is 160 feet from the Texas Pacific Coal and Oil Company lease."



Gentlemen:

Reference is made to letter dated November 28, 1956, from Mr. Winston G. Smith, Division Engineer for Austral Oil Exploration Company, Incorporated, a copy of which was forwarded you, and pertaining to their request for an administrative exception to the spacing rule for the drilling of their No. 3 State "B" well at a location 4290 feet from the south line and 160 feet from the east line of Section No. 1 in Township 16 South, Range 35 East in Lea County, New Mexico.

Gentlemen:

This letter is written to advise that Austral Oil Exploration Company Incorporated is intending to drill an unorthodox location to be known as our State D#3 well and located 4290' from the south line and 160' from the east line of Section 1, T-16-S, R-35-E, Lea County, New Mexico. Due to the topographic conditions of the airport runway, it is necessary to place this well within 160 feet of the east line of Section 1, and we are asking the New Mexico Oil Conservation Commission to grant an administrative exception to their spacing rule.

The New Mexico Oil Conservation Commission requires that in order for an administrative exception to their spacing rule be granted, the Texas Pacific Coal and Oil Company consent to the proposed location.

It is my understanding that our Mr. Gerald Faust talked with your Mr. Slagle today in regard to the location of this well with respect to the boundary line of the lease, and it was suggested that Texas Pacific Coal and Oil Company would consent to the drilling of the well in this location if Austral Oil Exploration Company Incorporated would upon request at some later date also agree to one location for a Texas Pacific Coal and Oil Company well which would offset our east lease line the distance of 160 feet. Please be advised that accordingly Austral Oil Exploration Company Incorporated will consent to the drilling of one well 160 feet from the east boundary of Section 1, to be located in either of the two forty acre blocks which have a common boundary line.

Enclosed for your information is a vicinity map showing Austral Oil Exploration Company Incorporated's leases in yellow and also showing the location of the well with respect to the runway of the Lea County Airport.

If you have no objection to the drilling of the well as shown, would you please advise the New Mexico Oil Conservation Commission, Santa Fe, New Mexico, of your consent for drilling of this well, with a carbon copy to this office.


