Dear Mr. Porter:

This is a request for administrative approval for an unorthodox gas well in the South Blanco Pictured Cliff Pool.

The well, El Paso Natural Gas Company Jicarilla No. 6-E, is located 694 feet from the South line and 800 feet from the East line of Section 20, Township 25 North, Range 4 West, N.M.P.M., Rio Arriba County, New Mexico.

The Southeast quarter of Section 20 is dedicated to this well. A high, narrow, rocky bluff runs Southwesterly through the center of the Southeast quarter of Section 20, making it impossible to locate the well the minimum distance of 790 feet from the South line of the Section, as required by the Oil Conservation Commission. It is, therefore, planned to locate the well unorthodox as the only alternative to the prohibitive high cost of constructing an orthodox location.

Since El Paso Natural Gas Company also holds all leases in the Northeast quarter of Section 29, Township 25 North, Range 4 West, the approval for an unorthodox location from other operators has not been sought.

I am enclosing two copies of the certified well location plat and two copies of the intention to drill.




