Gentlemen:

Petro-Atlas, Inc. respectfully submits its application for administrative approval of an unorthodox well location for its Horseshoe Canyon "B" #2, and offers the following in support:

1. Through a surveying error the HORSESHOE CANYON "B" #2 was staked 1746' FNL & 1122' FEL of Section 9, Township 30 North, Range 16 West, San Juan County, New Mexico. This well was completed as an oil well from the Gallup formation on December 3, 1958.
2. The location of the subject well was surveyed and staked August 2, 1958, and at that time it was believed that this well was located 1567' FNL & 953' FEL of Section 9, Township 30 North, Range 16 West.
3. The planned location of Horseshoe Canyon "B" #2 would have been in excess of 660' from the nearest well, and also, 2367' from the closest lease line. Therefore, the planned location would have conformed with the tolerances set out in Rule 104-C.
4. Neither geological or topographic advantages were gained by drilling the well at the location staked in error, rather than at the planned location. Additional expense was incurred in grading the location that was staked in error. In addition, geological evidence indicates that better sand conditions probably would have been encountered at the planned location.
5. A plat showing the location of the subject well, Horseshoe Canyon "B" #2, plus the lease ownership and well locations near or adjacent to this well is attached.
6. Petro-Atlas, Inc. is the owner of the lease, comprising the E/2 NE/4 Section 9-30N-16W, San Juan County, New Mexico, on which Horseshoe Canyon "B" #2 is located. Further, all operators owning interests in the acreage offsetting Horseshoe Canyon "B" #2 are notified by registered mail of this request.

Therefore, Petro-Atlas, Inc. requests that the Secretary of the Commission grant exception to Rule 104-C without notice and hearing and grant administrative approval.




