Pan American Petroleum Corporation hereby submits application for approval of an unorthodox well location for our C. M. Farnsworth "B" Well No. 3 located 1980 feet from the South line and 1650 feet from the West line and in the NE/4 SW/4 of Section 7, Township 26 South, Range 37 East, NMPM, Jalmat Gas Pool, Lea County, New Mexico.

This unorthodox well location was occasioned by the recompletion of the well which was previously completed as an oil well in the Jalmat Pool.

Also, this is an application for approval of a 481 acre non-standard gas proration unit in the Jalmat Gas Pool consisting of the following acreage:

TOWNSHIP 26 SOUTH, RANGE 37 EAST
W/2 and W/2 of E/2 of Section 7

This unit will be assigned to our C. M. Farnsworth "B" Well No. 3.

In support of our request for exception approval without notice and hearing to Rule 2 and Rule 5(A), respectively, of Order No. R-1670, the following is submitted:

1. Application is submitted in triplicate.
2. The proposed non-standard gas proration unit
 - (a) consists of contiguous quarter, quarter sections.
 - (b) lies wholly within a single governmental section.
 - (c) may reasonably be presumed to be productive of gas.
 - (d) length or width does not exceed 5280 feet.
 - (e) lies within the horizontal limits of the Jalmat Gas Pool.

3. By registered mail copies of this letter are being furnished all offset operators notifying that application is being made for an unorthodox well location and a non-standard proration unit.
4. A plat showing acreage to be dedicated, well location and offset ownership is attached.

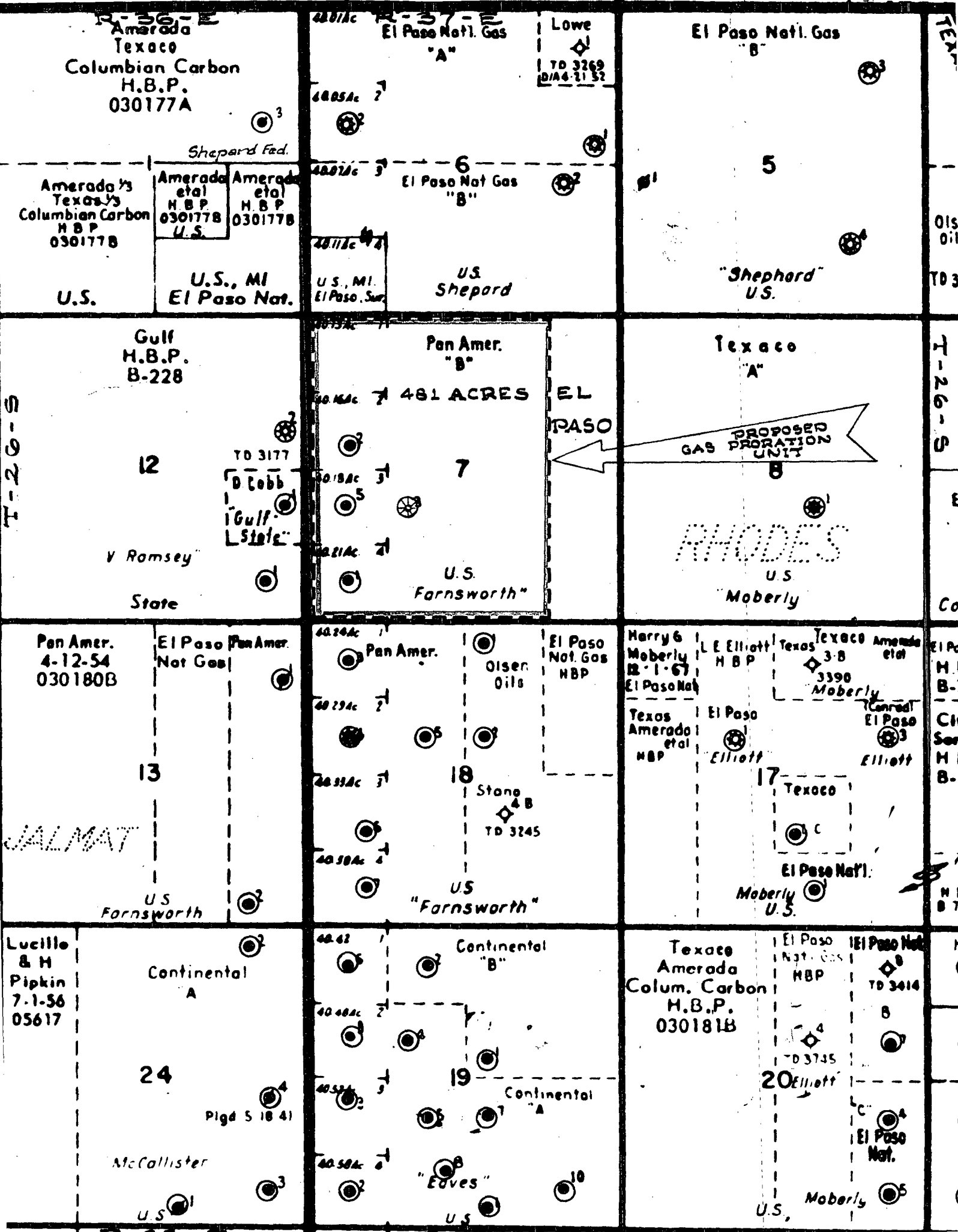
