This is a request for administrative approval for an unorthodox gas well location in the Basin Dakota Pool.


It is intended to locate the well, El Paso Natural Gas Co. Michener "A" No. 6, 1840 feet from the North line and 330 feet from the East line of Section 31, Township 28 North, Range 9 West, N.M.P.M., San Juan County, New Mexico. The N/2 of Section 31 is dedicated to the well.

As shown on the enclosed plat, the NE/4 of Section 31 consists of high bluffs, forming a box canyon with two existing wells, the Michener No. 2-A, completed in the Pictured Cliffs formation and the Michener No. 5-A completed in the Mesa Verde formation. The only accessible land for a well in the NE/4 is that which makes the location unorthodox. It is, therefore planned to make the location unorthodox in order that the extremely high cost of constructing an orthodox location be avoided.

Since El Paso Natural Gas Co. holds all leases within the 790' radius, the consent of any other operators has not been sought to said location. ✓

I am enclosing two copies of the certified well location plat, and two copies of the notice of intention to drill.



DETAILS OF WORK

It is intended to drill the well through the Dakota formation using rotary tools and to perforate and fracture all possible producing zones. Est. T. D. 6735'.

Casing Program:

- 9 5/8" @ 280' with 310 sacks cement circulated to surface.-100% excess to circulate.
- 4 1/2" @ 6735' cemented in three stages:
 - 1st stage - 260 sacks, 4% gel (50% excess to fill to 100' above the Gallup formation)
 - 2nd stage - 280 sacks, 8% gel, (50% excess to fill from 100' below the Point Lookout to 100' above the Cliff House formation.
 - 3rd stage - 560 sacks, 8% gel (50% excess to fill from 100' below the Pictured Cliffs to the surface.)

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
The N/2 of Section 31 is dedicated to the Dakota formation.


