Dear Sir:

Reference is made to the application of Marathon Oil Company, dated June 19, 1962, requesting authority to dually complete the Lea Unit, Well No. 9, in the Lea Pennsylvanian and Lea Devonian zones. The subject well is located 2130' from the East line and 660' from the North line of Section 13, Township 20 South, Range 34 East, Lea County, New Mexico.

It was originally proposed that this well would be completed as a Lea Devonian - Lea Bone Springs dual. An application requesting authority to effect this dual completion was submitted to the Commission on May 24, 1962, and was subsequently approved.

Due to the poor quality of the Bone Springs pays, as encountered in this well, it was concluded that a dual completion should be attempted in the Lea Pennsylvanian - Lea Devonian zones. The aforementioned application of June 19, 1962, was submitted, and was approved by Order No. MC-1212. The question has now been raised as to whether or not this order was also sufficient to constitute approval of the unorthodox well location in the Lea Pennsylvanian Gas Pool. Therefore, to clarify the records, it is respectfully requested that a supplemental order be issued administratively granting approval of the unorthodox well location. We trust that no waiting period will be necessary prior to the issuance of this order.






