¶ PROPOSED WILDCAT OIL WELL TO BE DRILLED TO A TOTAL DEPTH OF 11,500' AS A DEVONIAN TEST. 40 ACRES MORE OR LESS TO BE DEDICATED TO THIS WELL IS THE SE/4 SW/4 SEC. 28-22S-25E. IN THE EVENT A GAS WELL IS MADE THE S/2 OF SECTION 28 WILL BE DEDICATED TO THIS WELL.

¶ TOPOGRAPHY SURROUNDING THIS WELL IS DESCRIBED AS FOLLOWS: LOCATION IS ON SIDE OF MOUNTAIN, MOVING LOCATION FURTHER SOUTH WOULD REQUIRE DEEPER CUT INTO MOUNTAIN RESULTING IN EXCESSIVE DIRT WORK COSTS. THE WELL LOCATION IS 282' FROM THE NORTH QUARTER-QUARTER SECTION LINE, LACKING ONLY 48' BEING AN ORTHODOX LOCATION.
