Dear Sir:

Texas Pacific Oil Company respectfully submits this application for and requests administrative approval for a standard 160 acre gas unit with a non-standard location in the Blinebry and Tubb Gas pools consisting of the following acreage:

TOWNSHIP 22-S; RANGE 37-E  
NW/4 of Section 9  
660' FNL & 2130' FWL

This location being outside the boundaries for a standard location we are asking exception under Rule 104, Section D, Sub-Section II, Paragraph F of the Oil Conservation Commission Rules and Regulations.

In support of our request for exception approval without notice and hearing the following is submitted:

1. Gas Proration unit consists of contiguous quarter-quarter sections.
2. Lies wholly within a single governmental section.
3. The proposed gas proration unit may reasonably be presumed to be productive of gas.
4. A plat showing acreage to be dedicated, well location, and offset ownerships.
5. All offset operators have been furnished a copy of this application by certified mail.






