BTA Oil Producers hereby requests administrative approval to reenter the Simmons Federal Well #1, an unorthodox well site, located 828' FSL and 708' FWL Section 31, T-9-S, R-34-E, Lea County, New Mexico.

This well was originally drilled and abandoned in November, 1956, by J. E. Simmons.

We plan to reenter the Simmons well, clean out the well bore, and set 5½" casing at the original TD of 9775' with 300 sacks of cement. The proposed completion will be through casing perforations in the Bough C zone of the Pennsylvanian formation.

The enclosed data is submitted in support of this application. Also enclosed is a waiver signed by Midwest Oil Corporation, the only offset operator.

This well was originally drilled and abandoned in November, 1956, by J. E. Simmons as the Federal #1. The well was drilled to a T.D. of 9775' to test the interval producing in the Lane Wolfcamp Field. All strings of casing were run as indicated above.

It is planned to reenter the well, clean out to the old T.D. of 9775' and set 5 1/2" casing on bottom w/300 sx cement. Completion will be through casing perforations in the Bough C reservoir.




