RE: Application for Exception to Rule 2 of Order
No. R-1670-A for an Unorthodox well location,
Blanco Pictured Cliffs Gas Pool
San Juan County, New Mexico

Gentlemen:

Pubco Petroleum Corporation hereby submits its Application for Administrative approval for an unorthodox well location proposed to be located 2,670 feet from the East line and 1,450 feet from the South line of Section 36, Township 30 North, Range 9 West, N.M.P.M., San Juan County, New Mexico. The footage stated is based upon actual survey; the Section is oversize, but for purposes of drilling and operating, a standard section of 640 acres is presumed as approved by the Oil Conservation Commission on April 5, 1955 and the Commissioner of Public Lands on April 18, 1955.

In support of this Application, Pubco Petroleum Corporation states the following facts:

1. That the proposed unorthodox location is being so located due to the topographic conditions in the area. An orthodox location elsewhere in the proration unit would be situated on a mesa requiring excessive road and location costs. Damaged reservoir conditions are considered to exist at the only other orthodox location.
2. That the proposed unorthodox location is located on a Standard Gas proration unit comprising the SE/4 of Section 36, Township 30 North, Range 9 West, operated by Pubco Petroleum Corporation, said unit comprised of lands owned by the operator, Continental Oil Company and Tenneco Oil Company, subject to a Communitization Agreement approved by the Commissioner of Public Lands of the State of New Mexico under date of January 21, 1960.
3. That the well at this proposed unorthodox location will be identified as the Pubco Delhi State Com #1X well and will be drilled to a depth sufficient to penetrate the Pictured Cliffs formation.




