Gentlemen:

It is respectfully requested that the Commission grant to Wynn & Brooks, Operators and owners of the captioned location, an unorthodox location to drill at a distance 1510 feet FNL and 2090 feet FEL to a depth sufficient to complete in the Mesaverde and Dakota formations. It is necessary to drill at this location in order to be in a position out of the Largo Wash which intermittent stream flows with great abandon at times as evidenced by the fact that other operators who have drilled in the Wash proper have lost or almost lost wells in the past.

Plats showing surveyors location in relation to the topography of the Wash, Offset operators who have been notified of this request by certified mail on this date, and Offsetting wells, are enclosed as exhibits to this request.

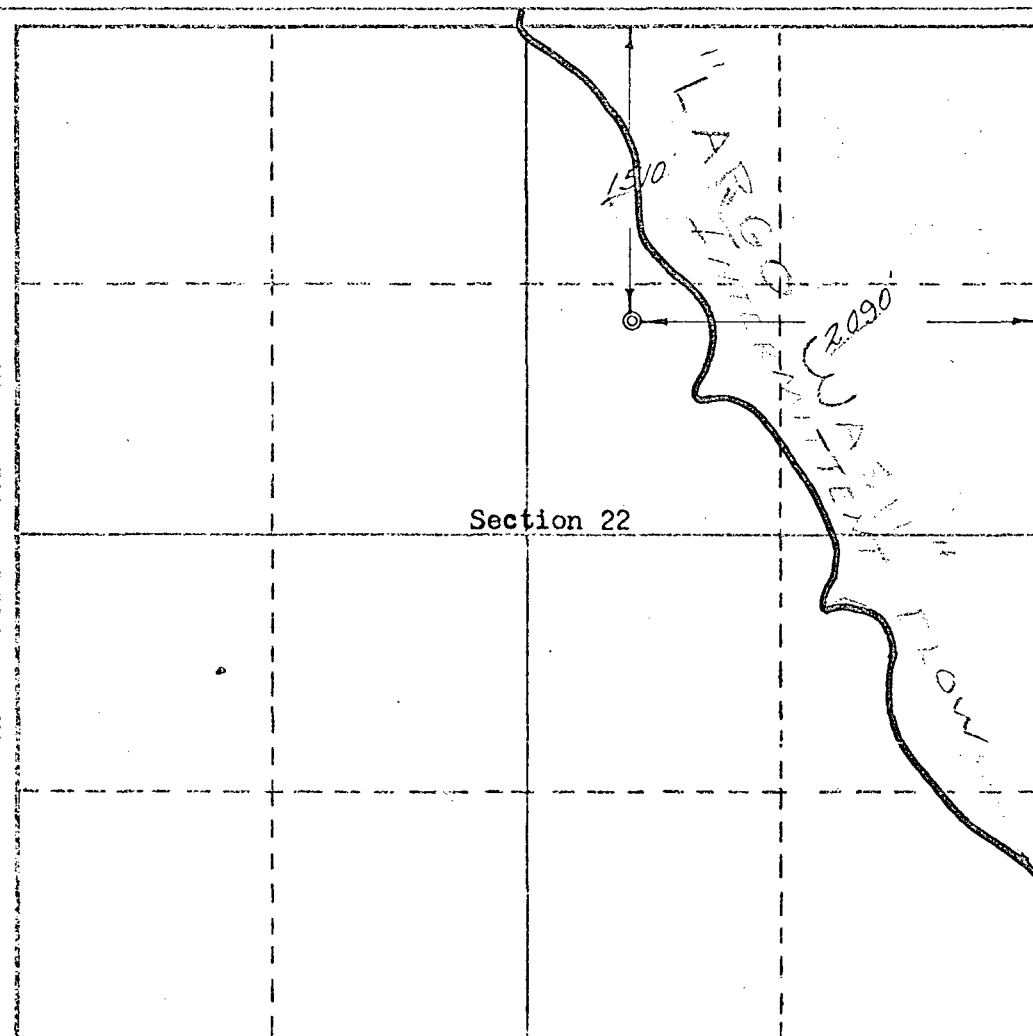

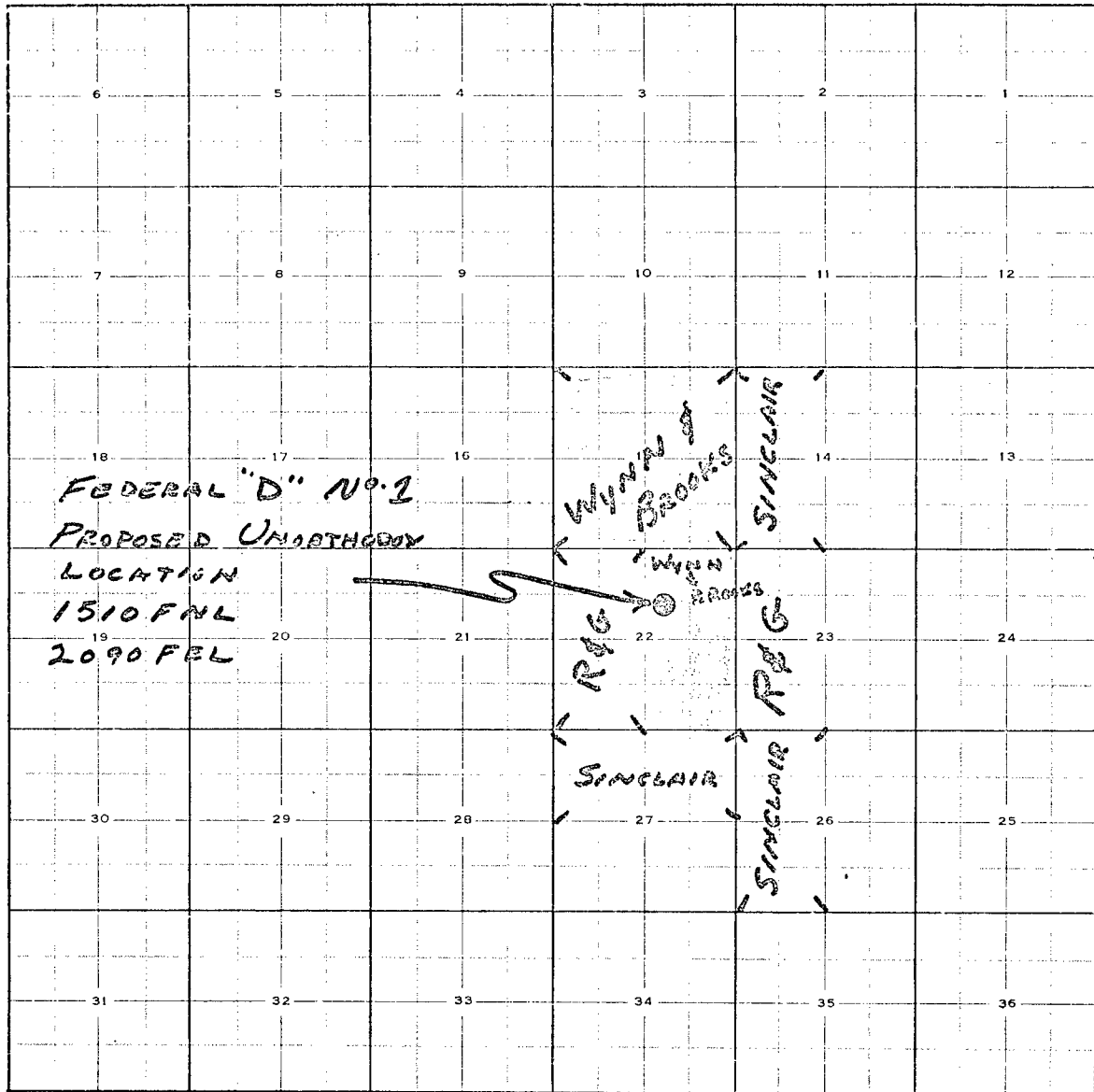

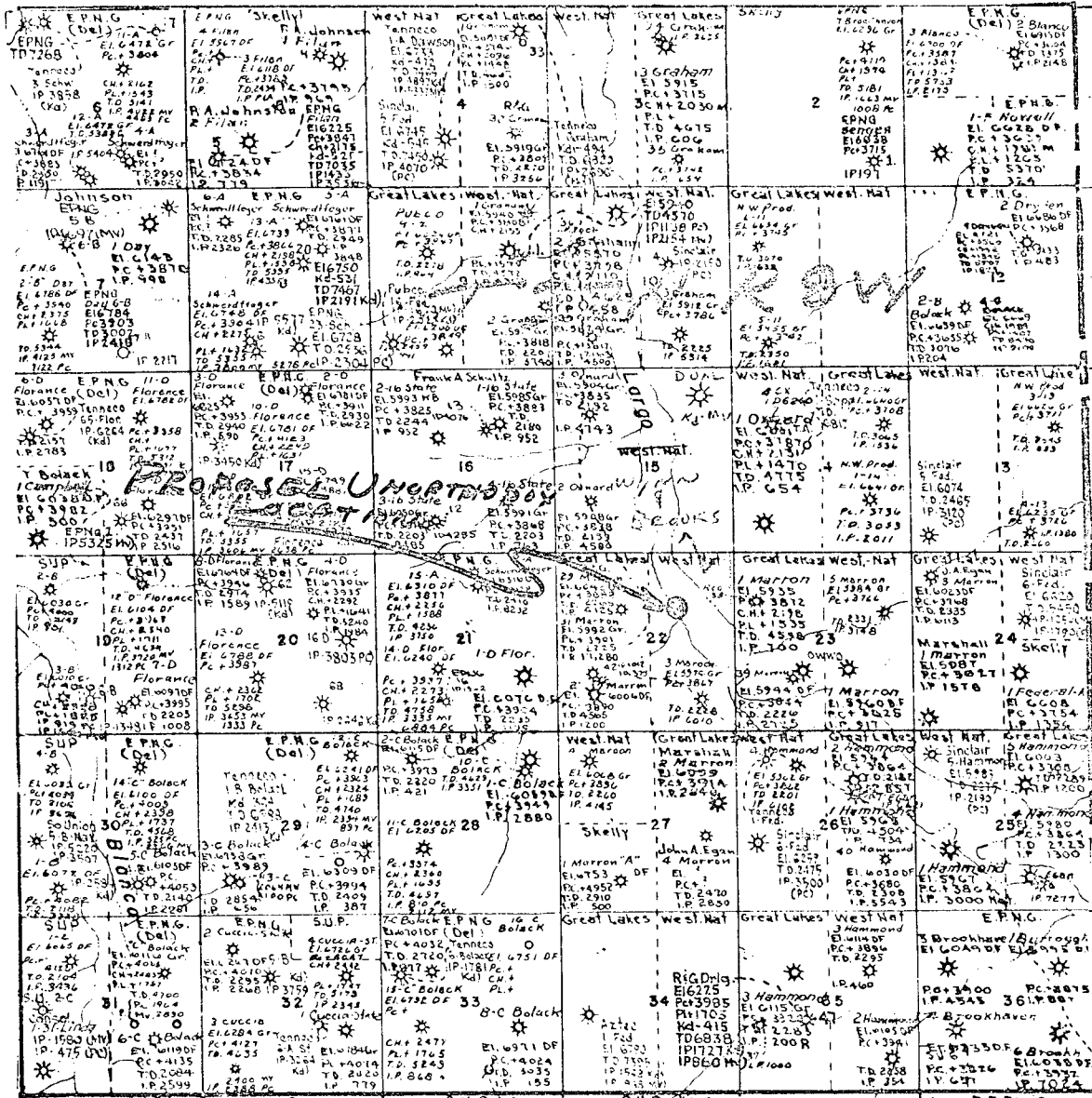


PLAT SHOWING OFFSET ACREAGE
