Dear Sir:

The subject well was drilled as a prospective Ellenburger Oil Well in Unit N, 330' FSL and 1980' FWL, Sec. 28, T-25-S, R-37-E, NMPM. The well was found to be non-productive in the Ellenburger Zone and was ultimately completed as a gas well in the Fusselman Zone.

It may be noted from the attached plat that this well location does not comply with Rule 104, A, I, (a) regarding the distance to the nearest side boundary, but does comply in other respects.

Giving consideration to the fact that the location was selected for an oil well, it is respectfully requested that exception to the portion of Rule 104, A, I, (a) violated, be granted administratively.

We are advising all offset operators of this request by copies of this letter.


