Gentlemen:

Amoco Production Company respectfully submits this application for Administrative approval of an unorthodox well location for the Hondo Federal Gas COM Well No. 1 located 1650' from the south line and 2310' from the east line of Section 27, T-17-S, R-27-E, NMPM, Logan Draw-Morrow Gas Pool Extension, Eddy County, New Mexico.

Due to topographical conditions it was necessary to move the well location 330' south and 330' west of the original site. The site area was in the Logan Draw arroyo bed area making it impractical and uneconomical to build a pad and/or re-route the arroyo bed. The proposed site is most practical and suitable for a well location topographically and maintain a desirable proration unit location.

Attached is a waiver of non-objection from the only offset operator, Atlantic Richfield Company.

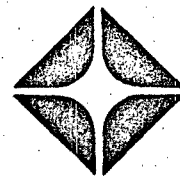

Reference is made to your application dated March 15,
1990 to amend Division Administration Order NSL-615,
which authorized a non-standard gas well location for the
Wondo Federal Gas Com Well No. 1 in the Logan
Draw-Morrow
Gas Pool
located 1650 feet from the South line
and 2310 feet from the East line
(Unit 5) of Section 27, Township
17 South, Range 27 East, N.M.S.,
Eddy County, New Mexico.

It is our understanding that the Morrow zone will
be plugged back in the subject well and recompleted in
the Undergirded Logan Draw-Walferus Gas Pool, which
pursuant to General Rule 104. C. II. (a), is located
at an non-standard gas well location for said pool. Also,
the SE $\frac{1}{4}$ of said Section 27 shall be dedicated to
said well forming a standard 160-acre gas spacing
and production unit for said pool, pursuant to General
Rule 104. B. and 104. C. II. (a).
