


Atlantic Richfield Company respectfully requests administrative approval of the following for the Atlantic State Well No. 1, located 330' from the East line and 990' from the South line of Section 25, Township 21 South, Range 35 East, Lea County, New Mexico.

1. Non-Standard 120-acre Gas Proration Unit for Eumont Gas Pool comprising the N/2 of the SE/4 and the SE/4 of the SE/4 of Section 25, T-21S, R-35E, Lea County, New Mexico.
2. Unorthodox location for the subject well.

At the present time, the proposed 120-acres is all one lease and is not assigned to any gas well. Upon completion in the Eumont Gas Pool, we request that the 120-acres be assigned to this well.

Atlantic Richfield took over operation of this well on May 1, 1974. The well has been shut-in since February 1971. Production from the present perforations (3806-20') is not economical. We propose to plug the well back and complete in the Yates Zone through selected perforations from 3588' to 3747' with 12 holes. We have already filed this intention on Form Nos. C-101 and C-103.


