To whom it may concern: Pogo Producing Company has filed an application with the New Mexico Oil Conservation Division to add perforations to the Corral Draw Well No. 2 saltwater disposal well, located 1580 feet from the south line and 1980 feet from the west line of Section 22, Township 25 South, Range 29 East, NMPM, Eddy County, New Mexico. The well is currently injecting into the Delaware formation in the interval from 3180-3333 feet subsurface, and applicant proposes to add injection perforations in the Delaware formation at 4068-4164 feet subsurface. The maximum injection rate is 600 BWPD, and the maximum injection pressure is 636 psi. Applicant's contact person is Thomas R. Land, Pogo Producing Company, P.O. Box 10340, Midland, Texas 79702, (432) 685-8100. Any interested person must file an objection or request for hearing with the Division within 15 days of publication of this notice.
