

We wish to submit for your consideration a request for the approval of the following non-standard locations, all located in Section 24, Township 29 North, Range 5 West, Rio Arriba County, New Mexico:

- Lone Star Industries, Inc., Schalk 52-2 (Pictured Cliffs)  
2470' from the North Line, 695' from the East Line.
- Lone Star Industries, Inc., Schalk 52-3 (Pictured Cliffs)  
2418' from the North Line, 858' from the West Line.
- Lone Star Industries, Inc., Schalk 52-4 (Pictured Cliffs)  
2058' from the South Line, 1312' from the East Line.
- Lone Star Industries, Inc., Schalk 52-5 (Mesa Verde)  
790' from the South Line, 790' from the West Line.
- Lone Star Industries, Inc., Schalk 52-6 (Mesa Verde)  
2456' from the North Line, 795' from the East Line.

A topographic map showing the existing terrain problems is enclosed.

Also, the ecological and environmental restrictions imposed by the Forest Service influenced the spotting of each location and it was the Forest Service specification that placed the No. 2 location less than 790' from the East Line of the Section.

Lone Star Industries, Inc. is the designated operator by way of a Farm-In from Aztec Oil and Gas Company, for all of Section 24, Township 29 North, Range 5 West, Rio Arriba County, New Mexico.
