

Gentlemen:

It is respectfully requested that Administration approval be granted for an unorthodox location for the above well in that the location was requested to be moved 100 feet east of the original location (standard) by the Bureau of Land Management for topographical reasons.

The attached topographic map shows the well as originally staked, 1980' FEL & 660' FSL of Section 21. At this location it would be necessary to make an approximate seven foot cut and fill which was objectionable to the Bureau of Land Management. By moving the location 100' east, this problem was somewhat alleviated.

The attached land plat shows that offset operators in this case are Continental Oil Company and Cooley & Dean. Both have been notified of this request by copy of this letter with attachment via Certified mail.







that they would notify the operator.


