Dear Sir:

Gulf Oil Corporation requests your administrative approval for an unorthodox location for S. J. Carr No.6, located 1650' FSL and 660' FWL of Section 10-24S-37E, Lea County, New Mexico. This well was recently recompleted in the Fowler Upper Yeso Pool. In support of this application, the following facts are submitted:

1. The Fowler Upper Yeso Pool Rules require that the well be located within 150' of the center of either quarter-quarter of the 80 acre proration unit, necessitating this request.
2. The recompletion of this well in the Fowler Upper Yeso Pool represents reasonable development of this pool.
3. Well No. 6 is located on the same 80 acre proration unit as S. J. Carr No. 8; however Well No. 8 is incapable of producing top allowable production.
4. This application is in the interest of conservation and the prevention of waste.
5. Copies of this application were mailed to offset operators October 15, 1976.

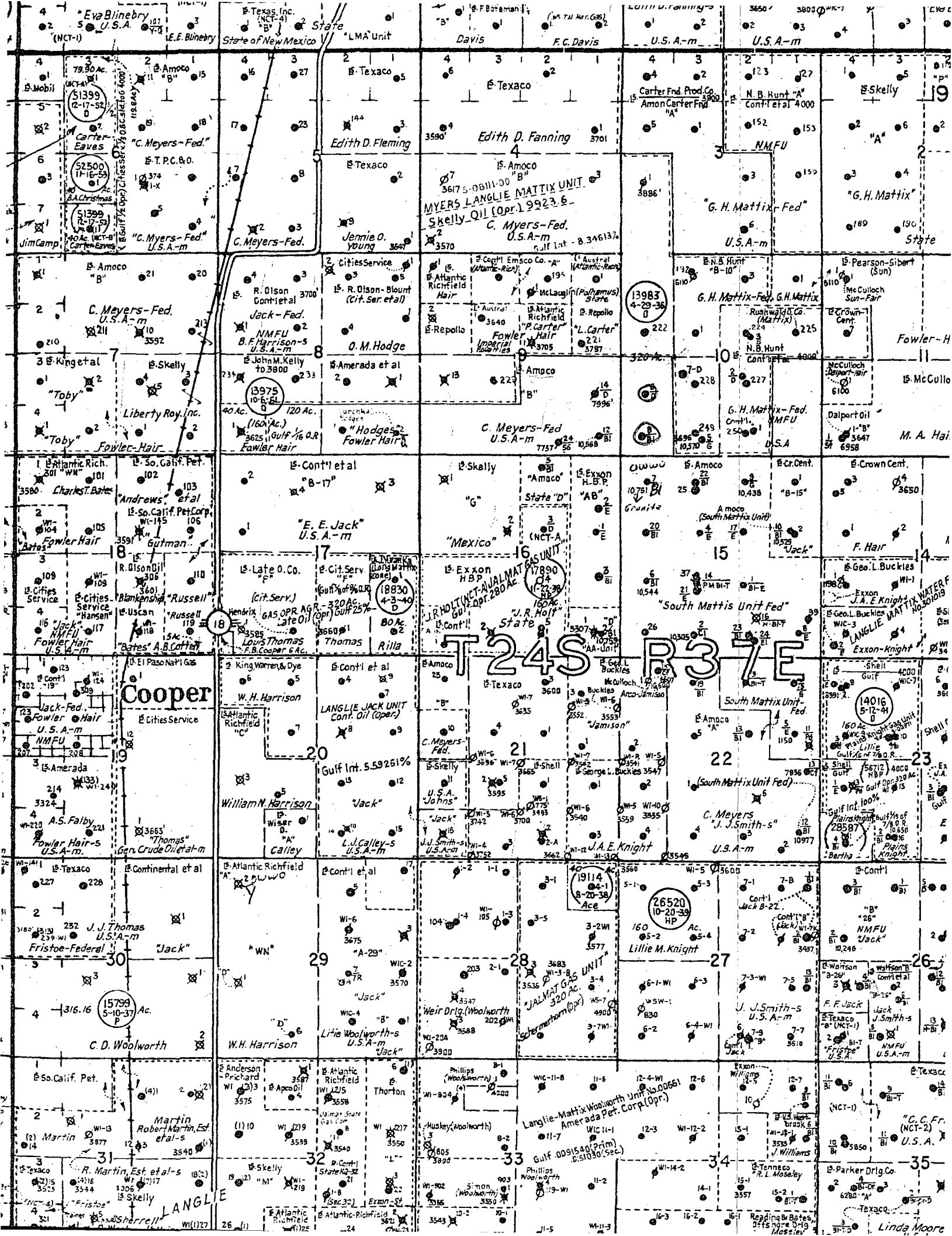
