This is a request for Administrative Approval on behalf of the above-referred-to operator for an unorthodox location.

The location is unorthodox due to the following reason:

Topography: It was necessary for the proposed location to be unorthodox due to a Pictured Cliffs well being at the only available orthodox location on the ridge in the SE4 SW4 of section 22-T28N-R11W.

The proposed location is between the Pictured Cliffs well and a ridge. To build a location in the canyon, west of the Pictured Cliff location and on the ridge east of the proposed location would be very expensive and if having to do so the operator would probably not drill the well.
