Dear Sir:

Consolidated Oil & Gas, Inc. respectfully requests your approval for authority to drill an infill well in the Blanco-Mesaverde Pool at an unorthodox location for that pool. Consolidated proposes to drill its Freeman No. 1-A well at a point 790 feet from the north line and 1980 feet from the west line of Section 11, Township 31 North, Range 13 West, N.M.P.M. San Juan County, New Mexico, dedicating thereto the N/2 of Section 11.

A second location in this half section offsetting our Freeman No. 1 well is deemed necessary to prevent waste, protect correlative rights and will result in the recovery of gas and liquid hydrocarbons that would not otherwise be recovered. The request for approval of an unorthodox location is necessitated by the proximity of a dwelling and associated farm buildings. The dwelling lies 420 feet to the west of the proposed location and movement of the location to the west to conform to spacing requirements as set forth by the Oil Conservation Commission of New Mexico would diminish the safety factors considered in choosing this location. 

DEVELOPMENT PLAN FOR SURFACE USE






