Dear Mr. Ramey:

This is a request for administrative approval for an unorthodox gas well location for a dual well in the Blanco Mesa Verde and Basin Dakota pools.

It is intended to locate the El Paso Natural Gas Company's San Juan 27-4 Unit No. 101 at 2010' from the North line and 1690' from the East line of Section 28, T 27 N, R 4 W, Rio Arriba County, New Mexico.

Rough terrain consisting of canyons and sandstone ledges in the north-east corner of this section makes it impossible to build an orthodox dual gas well location.

El Paso Natural Gas Company is the only operator of proration units offsetting the proposed unorthodox location.

Plats showing the proposed well location and the terrain of Section 28, along with an ownership plat, are attached.




