Gentlemen:

Devon Energy Production Company, L.P. ("Devon"), will assume temporary operations of the referenced well from Chevron MidContinent, L.P. for the purpose of recompleting the well to the Cisco formation from 8544' to 8553'. This well was drilled to a total depth of 10,575' in October 1981, completed in the Morrow formation (Catclaw Draw Morrow Gas Pool) and has produced until September 2005. The Artesia NMOCD has advised that a successful Cisco recompletion will be assigned to the Upper Penn Cisco Pool and that the surface location for the well will be an unorthodox location under the Upper Penn Cisco Pool Rules.


Inasmuch as the recompleted Cisco formation is located at an unorthodox location from that permitted by the current Upper Penn Cisco Pool Rules, Devon respectfully requests that the NMOCD administratively approve this application for an unorthodox location in accordance with Division Rule 104(F)(3). This unorthodox location affects the owners in the S/2 Section 13-T21S-R25E, being Chevron MidContinent, L.P., Fasken Oil & Ranch, Ltd., Bean Family Limited Partnership, Read & Stevens, Inc. and Devon ("affected parties") all of whom represent all of the owners in the recompletion of the Catclaw Draw Unit #16 and have either approved the recompletion or elected to be a non-consenting party to same. The affected parties have been given notice of this administrative application.
