



Dear Sir:

Delta Drilling Company hereby makes application for approval of an unorthodox gas well location and states:

- 1) Applicant plans to re-enter the #1 Unit State well located 660' FNL & 660' FWL of Section 30, Township 16 South, Range 33 East, N.M.P.M., Lea County New Mexico and attempt a completion in the Morrow formation.
- 2) Said well was originally drilled as a Morrow test and was subsequently re-entered and deepened to the Devonian formation. This re-entry resulted in the well being plugged and abandoned in 1962.
- 3) The N/2 of Section 30, Township 16 South, Range 33 East, N.M.P.M. will be dedicated to the well if the re-entry is successful in the Morrow.
- 4) Approval of the unorthodox location will be in the interest of conservation, prevention of waste and protection of correlative rights.

Inasmuch as this is a re-entry of an existing well we request administrative approval of the unorthodox location outlined herein.

Enclosed in support of this application are waivers from the offsetting operators and an information copy of our Application for Permit to Drill, Deepen, or Plug Back (Form C-101).

It is our intention to re-enter Unit-State well #1 originally P&Aed by Samedan Oil Corporation on 4/28/61 as a Devonian test. Records indicate that 13-3/8" 48# E-40 surface casing was set @ 364' and cemented with 305 sx. Also 8-5/8" 32# J-55 intermediate casing was set @ 4529' and cemented with 700 sx. TOC, by Temp survey, was found @ 2400'. Later 8-5/8 casing was cut off at 2363' and pulled. Plans call for rig up Workover Rig & wash clean to 4479' & run casing inspection log. Run 8-5/8" casing & tie back to casing at 2363' and cement with 600 sx Class "C". WOC 24 hrs. Test casing to 1500 psi for 30 min. Move in Roatry Rig & wash down to 13800'.






FIRST NIPPLE-UP


All components through the choke to be tested to 1500#
