



APPLICATION FOR ADMINISTRATIVE APPROVAL

Re: Unorthodox Location
Undesignated Farmington Gas Field
1575' FSL & 790" FEL
Section 25, T-29N, R-11W
San Juan County, New Mexico

Dear Sir:

Manana Gas, Inc. is proposing to drill a gas well in the above referenced location, and hereby request a spacing exception. The proposed well would be drilled on a 40 acre pro-ration unit in the NE/4 of the SE/4 of Section 25. The well location would be 100' south of our Aunt Maggie #1 Pictured Cliffs well. It would be 255' FSL of this 40 acre tract, which makes it 75' short of the 330' minimum required.

El Paso Natural Gas has a right-of-way for a high pressure and a low pressure gathering line 24' north of our Aunt Maggie #1. Directly north of their right-of-way is a hill with an almost perpendicular approach. It is impossible to move any further north from the proposed location due to the proximity of our Aunt Maggie #1 Pictured Cliffs well, the El Paso Natural Gas right-of-way, and the steep hill to the north.
