
Dear Mr. Stogner,



Due to surface relief and drainage issues on the surface the BLM surface use people have restricted the placement of any surface locations. The non-standard location that we have applied for is our third attempt to satisfy the BLM and still stake a location in this 40 acre tract. I spoke with Bryan and he said that he will place the well in the Artesia-Glorieta-Yeso pool (96830). However, the Glorieta Yeso zone will be encountered very close to the base of SDX's rights. If we are unable to complete in the Yeso due to a rights issue we will complete in the Red Lake Qn Gb Sa pool (51300). There are no special provisions in either of these pools. The entire NE/4 of section 21 is one lease (units A&B are a part of the same lease), therefore the ownership is identical. I hope this clears everything up. It sounds like I will be in Santa Fe, in a month or so, on a waterflood application. I will stop by to see you. Thanks for your help on this.

- 2) If this is Glorieta-Yeso Oil production, please check with Bryan Arrant and let me know which Pool it will be placed in. It seems to be

within one mile of two different Glorieta Yeso Pools and the Red Lake is not one of them.

- 3) For the pertinent pool, does any "special pool rules" pertaining to location apply?
- 3) The well will be encroaching on Unit B of Section 21 which is also operated by SDX Resources, Inc. Is ownership identical between Unit A and Unit B? If not, which working interest owners are different
