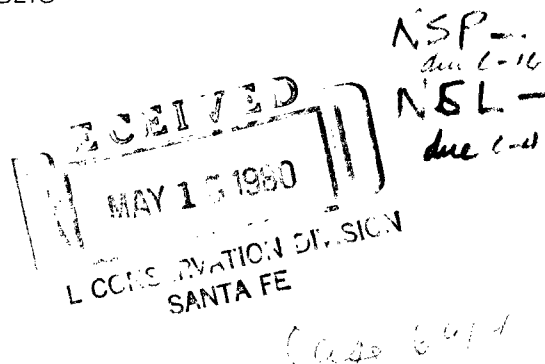

Dear Mr. Ramey:

Wilson Oil Company, by its undersigned attorneys, hereby applies for administrative approval of a non-standard unit and an unorthodox gas well location to permit Wilson, or someone on its behalf, to reenter the Wilson Oil Company State "JD" No. 1 Well located 1,650 feet from the South line and 1,980 feet from the West line of Section 29, Township 20 South, Range 36 East, N.M.P.M., Lea County, New Mexico, and attempt a gas completion in the Morrow formation, and to dedicate the S/2 of said Section 29 as the proration unit for the well. A plat showing ownership of all leases offsetting the non-standard unit is hereto attached.

The State "JD" No. 1 Well is located within one mile of the outer boundaries of both the North Osudo-Morrow Gas Pool and the Osudo-Morrow Gas Pool, but the State "JD" No. 1 Well is located closer to the North Osudo-Morrow Gas Pool. The North Osudo-Morrow Gas Pool Special Pool Rules providing, among other things, for 640-acre spacing units, were adopted in Case No. 3642, Order No. R-3305 by the Oil Conservation Commission.

Pursuant to Rule 3 of Order No. R-3305, Wilson certifies that the following facts exist:

- a) The non-standard unit consists of quarter-quarter sections or lots that are contiguous by a common bordering side.
- b) The non-standard unit lies wholly within a governmental section and contains less acreage than a standard unit.
- c) Wilson is this day furnishing all offset operators and all operators owning interests in Section 29 with copies of this application for administrative approval.
