Dear Mr. Ramey:

This is a request for administrative approval for an unorthodox gas well location in the Basin Dakota pool.

It is intended to locate the El Paso Natural Gas Company's San Juan 28-7 Unit #241E at 980' from the South line and 1840' from the East line of Section 9, T-28-N, R-7-W, Rio Arriba County, New Mexico.

Extremely rough terrain in the form of steep cliffs in the southeast corner of this section makes it impossible to build an orthodox gas well location.

El Paso operates all proration units offsetting the proposed unorthodox location.

Plats showing the proposed well location and the terrain of Section 9, along with an ownership plat, are attached.

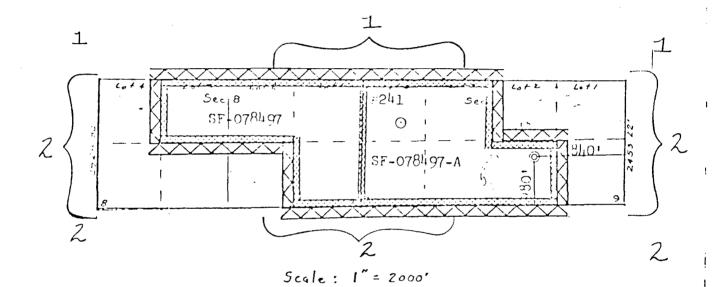
